

INSTRUCTIONS FOR OPENING IRREVOCABLE LETTERS OF CREDIT (AIR SHIPMENTS FROM STOUGHTON)



WHEN OPENING L/CS, PLEASE FOLLOW THE PROCEDURE OUTLINED BELOW:

1. All L/Cs must be advised through:

2. Draft must be **“At Sight”**. T/T reimbursement must be on an American bank, preferably in New York or an American branch of the opening bank. L/Cs not reimbursable as above will not be accepted.
3. T/T reimbursement claim allowed.
4. Beneficiary name as follows:

5. Section 45A Description of Goods: You must include the word “skins” after the variety (i.e.; Ranch Mink skins, Marten skins, Ranch Fox skins).
6. All shipments are Ex Warehouse. All shipments are collect. Shipments made from North American Airport. Country of origin: USA/CANADA/EU.
7. Interest, Storage and Insurance clause must be inserted as follows:
“Beneficiary allowed to draw in excess of L/C amount by not more than 9% of the L/C for Storage, Interest and Insurance charged from Prompt Date to estimated date of negotiation of L/C.
This charge to be shown on Commercial Invoice.”
8. All banking charges outside applicant’s country are for applicant’s account.
9. Last shipment date must be at least 25 days from the date L/C issued. On CITES skins, you must allow a minimum of 45 days from date of L/C issue. Following goods require CITES permits: Lynx, Lynx Cat, Polar Bear, Timber Wolf, and Otter. Please note that original CITES permit must accompany shipment and L/C should specify copy. The auction house will supply the CITES permit and packing list.
10. Expiry date must be at least 20 days after last shipment date.
11. Partial shipment must be allowed in case of shortage.
12. Air Way Bill: Shipments must be consigned to the opening bank, notify **“Accountee”**. Air Shipments must state: **“House Airway Bill Acceptable”**.
13. Documents supplied with each shipment with be:
a) Commercial Invoice
b) Packing List
c) House Airway Bill
14. To expedite shipments DO NOT have the L/C request copies of the **Export Certificate for Animal Products** or **Certificate of Origin** of the L/C.
15. Please state name of Freight forwarder.
16. Letters of Credit must be opened according to the Uniform Customs and Practice - UCP600

Certificate of origin and export certificate for animal products are supplied and issued through the appointed freight forwarders and are not the responsibility of the auction house.
